Play Area:

Flagpole:

Two quotes for the cost of erecting the pole were still outstanding. The total cost of the project was expected to be around £320. There was still a shortfall of around £200. Mr S Hodges had been approached to provide a plaque for the pole and Mr B Sampson was to help with the wording for it.

The Green Room:

The turnover for the last year had been around £8,500. 50% of this was profit. The Trustees were trying to encourage wider usage of the facilities and had drawn up an agenda for the

summer with the help of the cricket club. A TV licence had been purchased and a TV donated. This was planned to be used for special themed events.

Lawn Mower:

A lawn mower had been purchased and it was already in use.

Extension and Improvement Plans:

The Trustees were looking again at the plans drawn up in 2005 for additional facilities including a disabled toilet and they were considering the feasibility of reinstating the project.

025.2016 Updates

a) Renewable Energy Project

Mr B Sampson reported that the consultant was still awaiting the technical report from Pennine Biomass. A meeting had been set for 6th June 2016 with the consultant to discuss this report. He also reported that the government had withdrawn the financial support of such projects. The implications of this were to be investigated.

b) Highways and Pavements

Sinks Lane. It was reported that the potholes remained unrepaired and they continued to pose a hazard to drivers. The Clerk was asked to contact Area 1 Highways again. District Councillor R Ormston stated that he would bring the issue up himself with Highways. The Road by the pillar box had been repaired.

The Clerk was still awaiting quotes for the repair of the matting.
